Question #3. Tax Resolution Process

Was the Tax Resolution Process Explained? Taxpayers should know the tax resolution process and average timelines for resolving tax liabilities. For example, what legally binding information is required from the client / taxpayer to start the process? What steps will the tax professional be taking with the IRS?

They are marketing companies that hide behind all types of names. Some use legal and authoritative language to appear official.

Question #5. Managing Expectations

Did the Tax Resolution Professional, Company, or Firm provide trustworthy expectations? This topic is brought up because taxpayers have been referred and contracted to us from outside marketing companies in the past whereas the clients were ill informed. Anyone can tell you what you want to hear especially before a transaction. It's important for taxpayers with IRS problems to understand that until a fact finding is conducted by a tax professional (Enrolled Agent, CPA, Tax Attorney) no unreal promises should be made.

Here is a common sales Falsehood VS Reality.

- Falsehood: Your tax debt will be wiped out fresh start!
- Reality: Your tax debt will or may be expiring soon, you may or may not be eligible for a tax related hardship option. None of which can be determined by a tax resolution company until a licensed tax professional receives pertinent case information and a signed power of attorney.
